B.3. Type of allocation of quota places:

Quota places are allocated to the athlete(s) by name.

C. ATHLETE ELIGIBILITY

Compliance with the Olympic Charter and other relevant rules

All athletes must respect and comply with the provisions of the Olympic Charter currently in force, including but not limited to Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions).

Only those athletes who respect and comply with the Olympic Charter, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions, including the conditions of participation established by the IOC, plus the rules of IBA, may participate in the Olympic Games Paris 2024.

Age requirements

To be eligible to participate in the boxing tournament of the Olympic Games Paris 2024, athletes must be born between and including 1 January 1984 and 31 December 2005.

Additional IF eligibility criteria

Athletes must also comply with the following criteria:

- Adhere to the IBA Technical and Competition Rules outlined here (<u>link</u>), including all competition and anti-doping provisions.
- Additionally, athletes need to be ranked in the top 50 on the Olympic ranking list on 31 March 2024
- Additionally, athletes must comply with at least one of the three below eligibility criteria:
 - I. Participate in at least two events eligible for IBA Elite World ranking list points during the Olympic qualification period
 - II. Be allocated a quota place directly through the IBA Elite World Championships 2023
- III. Be allocated a quota place directly through the World Qualification Tournament 2024





D. QUALIFICATION PATHWAY

D.1. QUOTA PLACES

The Olympic qualification period will run from 01 January 2023 to (and including) 31 May 2024. **Men's Events:** For the Olympic Games Paris 2024, the 12 IBA lightest men's categories will be combined in pairs to form six Olympic categories for men. The heaviest IBA men's category will form the seventh Olympic category.

Qualification Pathway

Athletes will qualify for the Olympic categories on the basis of:

- Their final position in the IBA Elite Men & Women World Championships 2023
- Their final ranking in the IBA Olympic ranking lists of 31 December 2023 and 31 March 2024 for each Olympic category;
- Their final position in the World Qualification Tournament;
- Host country places;
- Universality places.

Events that are identified as qualification events shall be announced before the start of the qualification period

IBA will produce an IBA World Ranking matrix for each IBA Men's (13) and Women's (10) weight categories as indicated in the tables above that will be implemented during the Olympic qualification period. The IBA ranking list will be updated after the conclusion of each relative event. The points obtained will then serve as the basis for the IBA Olympic ranking lists serving the Olympic categories as stated below.

IBA will produce an IBA Olympic ranking list of the Men's and Women's Olympic categories that includes IBA World Ranking points earned, in each IBA Men's (13) and Women's (10) weight categories as indicated in the tables above, between 1 January 2023 and 31 March 2024. Where two IBA categories contribute to one Men's or Women's Olympic category, as indicated in the tables above in section D., points earned in either of the IBA categories will be combined cumulatively in the Olympic ranking list for the Men's or Women's Olympic category.

All athletes will be allowed to participate and accrue points in IBA events that appoint Olympic ranking points throughout the entire qualification period, (no matter if they have been already allocated and confirmed a quota place) as the final Olympic Ranking of 31 March 2024 will be used to form the seeding of the draw for the Olympic tournament.

26 Men 20 Women (Total 46 athletes)	Phase One Quota places will be allocated based on the Men's and Women's Elite IBA World Championships (Q3 and Q4 of 2023). For the Men's World Championships, both finalists in each of the 13 IBA categories (as indicated in the tables above) will be allocated a quota place for the respective Olympic category. A total of 26 quota places will be allocated. For the Women's World Championships, both finalists in each of the 10 IBA categories will be allocated a quota place. A total of 20 quota places will therefore be allocated. Where two athletes from the same NOC reach the finals of two IBA categories that contribute to a single Olympic category, the NOC will decide on the final quota allocation.
42 Men 36 Women (Total 78 athletes)	Phase two The highest six (6) ranked athletes in each of the Men's and Women's Olympic categories, according to the Olympic ranking lists as of 31 December 2023 will be allocated quota places, respecting the maximum quota per event per NOC. Athletes who have been allocated a quota place in phase one and confirmed by their respective NOC, will not be considered for phase two in their respective categories.

Phase three

In phase three IBA will ensure that all Confederations (EUBC, ASBC, OCBC, AFBC and AMBC) will have representation in every Olympic category. Quota places will be allocated based on the Olympic ranking list of 31 March 2024 as described in the below order.

- I. The seven host country quota places will be allocated to the athletes who rank highest according to the Olympic ranking lists as of 31 March 2024. If quota places have already been allocated to host country athletes in phase one and two, then these places shall be deducted from the host country quota places available for allocation in phase three.
- II. Universality quota places will be allocated based on applications and respecting the athlete eligibility criteria outlined in section C, according to the Olympic ranking list of 31 March 2024.
- III. Following Universality places confirmation quota places will be allocated to athletes in order to ensure the minimum participation of at least one athlete per continent per Olympic category, according to the Olympic ranking lists of 31 March 2024 and subject of the maximum quota places per Olympic category and to the fulfilment of the eligibility criteria outlined in section C. Athletes who have been allocated in phase one and two will be counted for these continental minimums*.
- IV. If following the steps I., II. & III. quota places are still available, then these quota places will be allocated to the next highest ranked eligible athletes according to the Olympic ranking lists as of 31 March 2024 for each of the Men's and Women's Olympic categories*.

*Two remaining places will be left for allocation of quota in each Olympic Category for phase four.

Phase four

A World Qualification Tournament will be held in May 2024, including all the Men's and Women's Olympic categories. The two finalists in each category will be allocated a quota place. If for any reason this tournament cannot take place, the respective quota places will be allocated to the next highest ranked eligible athletes according to the Olympic ranking lists as of 31 March 2024. Where NOCs have confirmed quota places in an Olympic category in phases one, two or three, they will not be permitted to enter further athletes in the same Olympic category at the World Qualification Tournament.





D.2. HOST COUNTRY QUOTA PLACES

The host country will be guaranteed a maximum **seven (7)** quota places, four (4) for Men and three (3) for Women.

After the completion of the IBA Elite Men World Championships the host country will be asked to confirm any quota places that they obtained during the IBA Elite Men World Championships 2023.

The host country quota places (4) will be recalculated by deducting any confirmed quota places. obtained through the IBA Elite Men World Championships

After the completion of the IBA Elite Women World Championships the host county will be asked if they confirm the quota that they secured during the IBA Elite Women World Championships 2023. The host country quota places (3) will be recalculated by deducting any confirmed quota places obtained through the IBA Elite Women World Championships

Athletes from the host country may be allocated further quota places according to the Olympic ranking list of 31 of December 2023 (phase 2) and the Olympic ranking list of 31 March 2024 (phase 3) respectively, in the same way as athletes from other NOCs. These quota places will be deducted from the total number of available quota places

The remaining host country quota places per gender will be recalculated with the deduction of the confirmed quota places obtained in phases 2 & 3.

D.3. UNIVERSALITY PLACES

Nine (9) Universality places, four for Men and five for Women athletes, are made available to eligible NOCs at the Olympic Games.

On 1 October 2023, the International Olympic Committee (IOC) will invite all eligible NOCs to submit their requests for Universality places. The deadline for NOCs to submit their requests is 15 January 2024. The Tripartite Commission will confirm on or before 7 June 2024, in writing, the allocation of Universality places to the relevant NOCs after the end of the qualification period for the sport concerned.

Detailed information on Universality places is contained in the "Games of the XXXIII Olympiad, Paris 2024 - Olympic Games Universality Places - Allocation Procedure and Regulations" document.

E. CONFIRMATION PROCESS FOR QUOTA PLACES

E.1. CONFIRMATION OF QUOTA PLACES





Following the conclusion of the respective IBA Men's and Women's Elite World Championships 2023, IBA will notify in writing the NOCs of the quota places they have obtained. Within seven working days of notification NOCs must confirm to IBA in writing if they wish to use these quota places.

On or before 5 January 2024, IBA will publish the IBA Olympic ranking lists of 31 December 2023 on its website (www.iba.sport) and inform in writing the respective NOCs of the quota places they have obtained. NOCs must confirm to IBA in writing if they wish to use these quota places by 16 January 2024.

On 3 April 2024, IBA will publish the IBA Olympic ranking lists of 31 March 2024 on its website (www.iba.sport). On 12 April 2024, IBA will inform in writing the respective NOCs of the quota places they have obtained. NOCs must confirm to IBA in writing if they wish to use these quota places by 23 April 2024.

Following the conclusion of the World Qualification Tournament in May 2024, IBA will inform in writing the respective NOCs of the quota places they have obtained from the World Qualification Tournament. Within seven working days from the IBA notification NOCs must confirm to IBA in writing if they wish to use these quota places.

E.2. CONFIRMATION OF HOST COUNTRY QUOTA PLACES

On 4 April 2024, IBA will inform in writing the host country NOC of any remaining host country places that are yet to be allocated. By 15 April 2024, the host country must confirm to IBA in writing use of its allocated places.

F. REALLOCATION OF UNUSED QUOTA PLACES

F.1. REALLOCATION OF UNUSED QUOTA PLACES

If an allocated quota place is not confirmed by the NOC by the confirmation of quota place deadline, or is declined by the NOC, the quota place will be reallocated as following:

- For quota places allocated in **phase one**, the quota places will be reallocated to the next highest ranked eligible athlete according to the Olympic ranking list of 31 of March 2024 for the respective Olympic category, respecting the maximum quota per event and per NOC;
- For quota places allocated in **phase two** of the qualification pathway, the quota place will be reallocated to the next highest ranked eligible athlete according to the Olympic ranking list of 31 March 2024 (phase three) of the respective Olympic category, respecting the maximum quota per event and per NOC. The quotas that have not been allocated in phase one and two will be allocated in phase three;
- For quota places allocated in **phase three** of the qualification pathway in order to meet the continental criteria mentioned in point C (eligibility), the quota place will be reallocated to the next highest ranked eligible athlete of that continent according to the Olympic ranking list of 31





March 2024 for the respective category, subject to the fulfilment of the eligibility criteria outlined in section C, respecting the maximum quota per event and per NOC;

- For remaining quota places allocated in **phase three** of the qualification pathway, the quota place will be reallocated to the next highest ranked eligible athlete according to the Olympic ranking list of 31 March 2024 for the respective Olympic category, respecting the maximum quota per event and per NOC;
- For quota places allocated in phase four of the qualification pathway, the quota place will be reallocated to the next highest ranked eligible athlete according to the Olympic ranking list of 31 March 2024 for the respective Olympic category, respecting the maximum quota per event and per NOC;

F.2. REALLOCATION OF UNUSED HOST COUNTRY QUOTA PLACES

Allocated host country place(s) not confirmed by the host country NOC by the confirmation of quota places deadline or declined by the host country NOC will be reallocated to the next highest ranked eligible athlete according to the Olympic qualification list of 31 March 2024 for the respective Olympic category, subject to fulfilment of the continental criteria outlined for phase 3 in the qualification pathway and respecting the maximum quota per event and per NOC.

F.3. Reallocation of unused Universality Places

If a Universality place is not confirmed by the NOC by the confirmation of quota place deadline, or is declined by the NOC, this place will be reallocated to the next highest ranked eligible athlete according to the Olympic ranking list of 31 March 2024 for the respective Olympic category and respecting the maximum quota per event and per NOC.
